Q-Tel™ 2034 is used when internal bonding (sheath continuity) is required and Q-Tel™ 2035 is used when an external bond or insulating joint is required. Royal Adhesives & Sealants Canada Ltd. also offers a very useful accessory for this Product. Q-Tel™ 2077 Adapter Hose is used to fill the Q-Tel™ 2034/ Q-Tel™ 2035 Cable Plugging Closure Kit sleeve where there is no space available to connect the plugging compound kit directly to the sleeve.
