- Screws are formed from AISI 1018 Hardened Steel.
- $\bullet$  The screws are #8 x 1" slotted hex washer tapping screws. They are equipped with a higher than standard head and a special Type "17" point to ease driving. They also feature a special coarse thread for superior hold in wood by preventing splintering.
- Screws have an unthreaded section under head to prevent over-torquing.
- A polypropylene bushing is provided to minimize torque and to assure that fastener installation is straight.
- Clips are powder coated for maximum corrosion resistance.
- Standard color is black. Other colors are available by request.


